No irrigation water taps are permitted prior to domestic water meter placement.</b></p> <p>2) No construction/equipment noise in residential areas before 7AM.</p> <p>3) Building permits &amp; APPROVED PLANS must be posted on the front of the home and be visible and accessible to the inspector.</p> <p>4) Inspections are required by the engineering inspector for all work within the public right of way including but not limited to : subgrade compaction , driveway approach and sidewalk forms and concrete finishing , and drainage swales.
