No irrigation water taps are permitted prior to domestic water meter placement.</b>  2) No construction/equipment noise in residential areas before 7AM.  3) Building permits & APPROVED PLANS must be posted on the front of the home and be visible and accessible to the inspector.  4) Inspections are required by the engineering inspector for all work within the public right of way including but not limited to : subgrade compaction , driveway approach and sidewalk forms and concrete finishing , and drainage swales. Please contact the Engineering department at (509) 545 3444 for more information and to schedule inspections .  5) The construction permit is issued with the understanding the submitted site and civil plans are accurate . If, during construction , inaccuracies are discovered, the City reserves the right to modify previous permit conditions and reviews and, if necessary, suspend work until corrections are addressed , reviewed and approved by City staff.  6) Your building plans have been reviewed by the building , planning & fire department. The civil plans submitted to the city engineer may still be under review and pending approval . It is the responsibility of the applicant to ensure an approved set of civil plans have been issued and are on site prior to any underground civil work being performed or inspected . A final inspection will not be performed until all issues are resolved .  7) The accuracy, location and existence of easements as well as property lines are the sole responsibility of owner. It is the responsibility of the owner to seek permissions from easement holders for the placement and improvements within easements . Further, any improvements created , constructed or otherwise permanently placed in any easement is the sole responsibility of the owner including the removal of said improvement should that be necessary .
